 - A. New Location Calculations : Executive Director Dennis Cyphers gave report on the cost of the move for the main office relocation. He stated that the total cost of

the move was \$18,365, not included in this amount is the replacement value of the furniture and equipment that had to be disposed of, which the Finance Director estimates would exceed \$50,000.

Mr. Cyphers stated that the rent for Corporate Way office was \$ 6,841 per month, and included electricity, garbage, lawn maintenance, and security system. Janitoral services at Corporate Way office were about \$350 per month. Rent for the new office is \$5250.00 per month and includes garbage, janiforial services, and lawn maintenance. Electricity amount averge about \$380 per month.
